# Consensual Agreement with Buyers of Puppies

You have decided to buy a puppy whose breeder has invested much love and time to provide you with a healthy Belgian Shepherd dog that will be optimally qualified to share your life over the years. The German Club for Belgian Shepherd Dogs (Deutscher Klub für Belgische Schäferhunde DKBS e.V.) supports the breeder in this endeavor. Our aim is to bring out the natural qualities of the Belgian Shepherd as a genetically healthy breed and to enhance these qualities by strict breeding regulations (Statutes DKBS e.V. §3.1). The animal's character, its social compatibility, constitution and appearance as well as its suitability as breeding stock and the qualities as a working dog are to be promoted, maintained and consolidated (Statutes DKBS §2.1a). In the long run, this can only be carried out if data from as many dogs as possible is secured and evaluated. It is in this respect that we ask you for your support.

Your personal details are registered for printing the pedigree and to keep the breeding records of the DKBS, so as to send you questionnares on health matters and the form for the x-ray diagnosis; upon completion of this x-ray examination, the advance deposit for it will be refunded.

## The DKBS respects your privacy and your personal rights.

We protect personal data and consider the protection of your privacy as a genuine matter.

## Use and passing on of personal data and its limitation:

The DKBS uses your personal data for printig the pedigree and to keep the breeding records as well as for maintaining health provisions in breeding, for shows and sports wherever necessary. Besides we publicize data relevant to breeding, shows and sports results, and we print photographs of your dog at meetings of the DKBS in the breeding records, the Club News, and our homepage. The involved persons are obliged to maintain discretion and to adhere to our codices of conduct.

#### A matter of choice

The DKBS would like to be able to use your personal data to inform you of our activities and to invite you to our events.

You will receive two copies of the Club News (Club Nachrichten) without commitment plus information from the sections of the Club in your vicinity (Landesgruppen) about meetings and events in this region.

# Your right to information

Upon request, DKBS will promptly and in writing inform you according to legal requirements if and which personal data are registered with us.

Should there be any errors in spite of our efforts to keep our records straight, we will of course correct them at your request.

#### Security

DKBS uses technical and organizational safety measures to protect your data on our records against accidental or deliberate manipulation, loss or destruction, or access by nonauthorized persons. Our safety measures are constantly improved in accordance with technical progress.

## Storage of your data

We save your personal data no longer than necessary for the statutory aims of DKBS.
